In September of 2019, behemoth retailer Walmart announced its goal to become "America's Neighborhood Health Destination" and launched its first Walmart Health center in Dallas, Georgia. The center offers primary care, labs, X-rays, EKG scans, counseling, dental, optical, hearing and community health education services for cheap. Shoppers can get a medical checkup for \$30, a teeth cleaning for \$25 and a mental health consultation for \$1 a minute, without insurance.
