Uplift Family Services Partners with Health Agencies to Serve More Individuals in Santa Clara County

With part of the two-year \$4,000,000 SAMHSA grant, Uplift Family Services will form a consortium with School Health Clinics of Santa Clara County and Pacific Clinics to create a Certified Community Behavioral Health Clinic (CCBHC) to serve 2,000 low-income individuals in Santa Clara County. This consortium is among 200 behavioral health organizations and health centers in the nation, and one of five in California, to become a CCBHC.

4th DCA Affirms Mental Healthcare Providers Owe No Legal Duty to Warn Unidentifiable Potential Victims

Fourth DCA joined the majority of its sister courts in finding that mental health providers owe no legal duty to warn their patients' potential victims because "the unpredictable nature of . . . mental health patient[s'] future behavior" makes it nearly impossible for mental health care providers to foresee potential harm against others, control the risk, and identify individual potential victims, the elements one must satisfy to establish a legal duty.
